5. No Escalation shall be payable on prices.

#### **General Notes:-**

1. Since the Government of India has introduced Goods and Services Tax (GST), so bidder shall include the effects of GST while quoting the rates and nothing extra would be paid.
2. Income Tax and all applicable taxes will be deducted from the contractors all bills on Gross amount as per Govt. rules and as made applicable by Govt. from time to time.
3. **The Bidders intending to participate in this Tender are required to get enrolled on the above mentioned website. Enrolment on the above mentioned Portal is mandatory. As the online Bids are required to be digitally signed, Bidders are required to obtain Class – II Digital Signature Certificates (DSCs). 4. The Firm / Agency / Contractor / Bidder who has been blacklisted by Department / Board / Corporation of Central Government or any State Government shall not be eligible to bid for this work.
5. The KMC reserves the right to verify the particulars furnished by the applicant independently. If any information furnished by the applicant is found to be incorrect at a later stage, the Firm / Agency / Contractor/Bidder shall be liable to be debarred from all




future Biding in the Department. Besides blacklisting the Firm / Agency / Contractor/ Bidder, the legal action will also be initiated and allotment shall be liable to be cancelled.

6. KMC. reserves the right to accept or reject any or all bids without assigning any reasons. No Bidder shall have any cause of action or claim against the KMC. For rejection of his Bid and will not be bound to accept the lowest or any other tender.
7. The Bid should be accompanied with proof of GST registration certificate.
8. If any Firm / Agency / Contractor/ Bidder withdraws his Bid prior to expiry of validity period as mentioned above or mutually extended period or makes modifications in the rates, terms and conditions of the Bid within the said validity period, which are not acceptable to the **KMC**, or fails to commence the work in the specified period/ fails to execute the agreement, the **KMC** shall without prejudice to any other right or remedy be at liberty to forfeit the amount of earnest money given in any form absolutely. If any Bidder, who having submitted a Bid does not execute the agreement or start the work or does not complete the work and the work has to be put to re-Biding, he shall stand debarred from participating in such re-Biding in addition to forfeiture of earnest money/ security deposit and other action under agreement. If there is strong justification of believing that the Bidder or his authorized has been guilty of mal-practices such as submission of forged documents, influencing individually or politically, his offer will be liable to rejection and in such case his earnest money shall be forfeited.
9. The **KMC** will not be responsible for any delay on account of late submission of Bid.
10. The acceptance of the Bid will rest with the **KMC** who does not bind itself to accept the lowest Bid, and reserves to itself the **KMC** to reject any or all the Bids received without assigning any reason.
11. No refund of Bid fee is claimable for Bids not accepted.
12. In case of any variation in nomenclature /typing error in the online bid documents and approved NIT, the provision of approved NIT will prevail and bidder shall have no claim, whatsoever on this account. In addition, the work is to be carried out as per provisions of the latest Central Public Health & Environmental Engineering Organization (CPHEEO) manual/ BIS Codes and the bidder has to submit his bid accordingly. Any variation in NIT, not consistent with the BIS Codes and Manual by Central Public Health & Environmental Engineering Organization (CPHEEO); the provisions of NIT will prevail.
13. All other conditions shall be prevailing as detailed out in the Bid document (in the respective sections/volumes).


