- 1- In order to participate in the tenders floated using thee-Procurement System, all contractors/bidders are required to get enrolled on thee-Procurement portal <http://eproc.cgstate.gov.in>.
- 2- The bids submitted online should be signed electronically with a Digital Certificate to establish the identity of the bidder bidding online. The registered contractors may obtain information required to issuance of Digital Certificate from e-Procurement system Mjunction Raipur.
- 3- For submitting the bids online, the contractors/bidders are required to make online payment using the electronic payments gateway service Bid Hash Submission Fees mentioned above the different modes of electronic payments accepted on the e-Procurement System is available and can be viewed online on the e-Procurement Website(<http://eproc.cgstate.gov.in>).
- 4- Tender Download, Submit Bid Hash online, Submission of Bids, EMD (ONLINE ONLY) or FDR, TDR and other Documents and other activities will be governed by the time schedules given under key Date
- 5- The Bidders has to submit (Upload Scan Copies/fill) his offer/credentials online as required in the tender in the online templates in relevant envelopes. The Bidders may refer Help Manual available online to perform their online activities.
- 6- The Commissioner, MUNICIPAL CORPORATION KORBA reserves the right to reject any part of/whole tender without assigning any reason and to restrict the list of pre-qualified tenderer to any number deemed fit by it.
- 7- Before the deadline for submission of tender the Commissioner MUNICIPAL CORPORATION KORBA may modify the tender document by issuing amendment. (Any amendment thus issued shall be part of the tender and shall be published on web site)

8- All the contractors are required to submit all documents online only

- a. Copy of Registration certificates. (Unified Registration System e-Registration 'PWD Chhattisgarh).
- b. The Earnest Money Should be Deposit Online as specified in the Tender-documents.
- c. Demand Draft of Processing Fees.
- d. Affidavit in Original
- e. Tender document fee with detail
- f. Earnest money deposit(emd)with detail.
- g. Valid Bank Solvency of 15% value of N.I.T. not older than the date of NIT in bank letter head.

10. Required documents of qualified tenderer shall be opened online on the prescribed date and time as per Notice Inviting Tender. After verification of proper and other required documents financial offers of such qualified bidders shall be opened online by the Commissioner, MUNICIPAL CORPORATION KORBA (C.G.) in the presence of the tenderer (s)/ representative who choose to attend at that time.


11. Additional performance shall be deposited by the successful bidder at the time of signing of agreement when the bid amount is seriously unbalanced. i.e., less than the estimated cost by more than 10% in such an event the successful bidder will deposit the additional performance security to the extent of differential cost of bid amount and 90% of the estimated cost in shape of Bank guarantee of Nationalized Bank in favor of Commissioner MUNICIPAL CORPORATION KORBA (C.G.) in Addition to EMD failing which the tender in this favor shall be liable for Rejection.

12. Other Details can be seen in the tender documents.

13. It is mandatory for bidder to submit all mandatory/required documents in online in website <http://eproc.cgstate.gov.in>. Any documents which are not submitted in online but submitted physically will not be accepted.
14. Bidder has to submit all the mandatory/required documents, if the mandatory/required documents not submitted by bidder then bid will be disqualified without any further clarification.
15. Joint Venture / Consortium is not allowed.
16. The Technical Document of the contractors have to be Seal and Signed (originally) before submitting the bids online.
17. If any document as required is not received as per the desired form, then the Bidder will be disqualified without any further clarification and his financial bid will not be opened.
18. Tenderers are required to submit all documents/information with the technical tender as required in the NIT or elsewhere in the Tender Document, otherwise it shall lead to rejection of bids.
