6.1 Experience certificate of successful completion of work of same nature in contractor's/ firm's/company's own name indicating agreement no., work order no and date, amount of contract, stipulated period of completion, actual period of completion during last five years i.e. . 2018-2023. The certificate should be issued by an officer not below the rank of Executive Engineer.

6.2 The details of works in hand indicating name of work, Agreement no., work order no. and date, amount of contract, period of completion, value of work done and balance work in hand on the date of submission of Tender duly notarized.

6.3 Valid registration certificate in appropriate class under Unified Registration System E-Registration.

6.4 Financial turn over on works during last five financial years i.e. 2018-2023.

6.5 Cess @ 1% (one percent only) shall be deducted at source, from every bill of contractor under "Building and other Construction for workers welfare, cess Act-1996"

6.6 It is mandatory for the contractor(s) to get himself/themselves registered with "Chhattisgarh Building and other construction welfare board" within one month after receiving work order.

7.0 A prebid meeting in this context shall be held in the office of the COMMISSIONER KMC Korba on Dated 07.08.2023 at 11.00 AM to 1.00 AM for preparation of common set of conditions on the basis of which the contractors shall quote their offers

8.0 Experience of Eligibility

Must have successfully done atleast one similar work of not less than 25 MLD water works in a single contract for operation and maintenance of water supply schemes of state /central government for a period not less than 12 months in his own name of the proprietor/firm/company.
